

Corel License for Learning Certificate Terms and Conditions

By purchasing Corel License for Learning Licenses and installing such authorized copies, you irrevocably agree to be bound by and comply with the following terms and conditions:

1. All Use of the Software by the entity which has purchased the Corel License for Learning Licenses and/or their Qualified Institutions ("You") shall be in accordance with the End User License Agreement ("EULA") accompanying the original copy of the Software purchased by You and the terms and conditions set forth in this Corel License for Learning Certificate ("Certificate"). You shall remain fully liable for the actions and omissions of all of Your participating Qualified Institutions for all rights and obligations granted under this Certificate. You must qualify as a Qualified Institution throughout the term of this Agreement. In the event of a conflict between the EULA and these terms and conditions, these terms and conditions shall prevail.
2. Subject to Your compliance with the EULA and these terms and conditions, Corel grants You the following non-exclusive and non-transferable rights to:
 - i) Install and Use one or more copies of the Software by Authorized Users;
 - ii) Utilize the Multi-Version Licence for some or all of the Software;
 - iii) Utilize the Multi-Lingual Licence for some or all of the Software;
 - iv) Utilize the Multi-Platform Licence for some or all of the Software.
 - v) Utilize the Home/Laptop Use Licence for some or all of the Software only for teachers, staff and faculties of Your Qualified Institutions;
 - vi) Create such archival copies of the Software as is necessary and reasonable in support of the Use of the Software; and
 - vii) Distribute copies of media and Documentation for the Software purchased from a COREL Authorized Academic Reseller to Authorized Users.
3. **Term.** The term of this Certificate is one year and may be renewed in accordance with Paragraph 4 herein for additional one year terms.
4. **Renewal.** Fifteen (15) days prior to the end of each Annual Period, You shall purchase from a COREL Authorized Academic Reseller, sufficient licenses to support Your level of Use of the Software.
5. **Termination.** This Certificate will terminate immediately in the event: (i) You fail to purchase sufficient licenses to support Your level of Use of the Software from a COREL Authorized Academic Reseller in accordance with Paragraph 4; or (ii) on the thirtieth (30th) day after one party gives the other written notice of breach by the other of any material term or condition of this Certificate unless the breach is cured before that day.
6. **Effect of Termination or Expiration.** Upon termination or expiration of this Certificate Your rights under this Certificate shall immediately expire. Termination of this Certificate shall not affect Customer's rights under any EULA accompanying shrink-wrapped version of Academic Software purchased by You from a COREL Authorized Academic Reseller. In addition, upon expiration of this Certificate, You shall have the option to purchase, from a COREL Authorized Academic Reseller, Your then current and valid licences at a suggested list price equal to two and a half (2.5) times the then current Software Prices provided that You: (i) provide written notice within thirty (30) days prior to the expiration of this Certificate to COREL or to a COREL Authorized Academic Reseller that You are exercising Your option to purchase Your then current and valid licences; (ii) submit a letter certified by an authorized representative of You which sets out the total number of copies of the Software In Use by You; and (iii) provide evidence of the purchase, from a COREL Authorized Academic Reseller, of sufficient licences to support Your level of Use. In the event You choose to exercise such option to purchase, Your Use of such license shall be in accordance with the EULA accompanying the original shrink wrapped version of the Software.
7. The following definitions shall apply:
 - Annual Period.** means the period beginning on the first day of the month following the Effective Date and ending one (1) year thereafter, and each consecutive one-year period thereafter that this Certificate is renewed in accordance with Paragraph 4.
 - Authorized User.** means any student, teacher, staff or faculty member of a Qualified Institution.
 - Documentation.** means the end user manuals in hard copy and/or electronic format relating to the Software and provided with the standard, retail, shrinkwrap versions of the Software.
 - Effective Date.** means the date of issue of the Corel License for Learning License Certificate.
 - Licensed Works.** means, collectively, the Documentation, Software and any Upgrades and Updates licenced by You under this Certificate.
 - Multi-Lingual Licence.** means a licence to Use any or all equivalent supported language academic versions of the Software in support of a single user on one machine at any one time. Nothing in this Certificate should be construed to warrant or imply that any new language version will be produced for any Software product or, if so produced, when such version will be made commercially available.
 - Multi-Platform Licence.** means a licence to Use equivalent versions of the Software on multiple operating system platforms.
 - Multi-Version Licence.** means a licence to Use different versions of the Software.
 - New Product.** means either an entirely new Software product or a major revision of Software released by COREL during the term of this Certificate that is consistently designated by COREL as a "new product" rather than as an Upgrade. If a question arises as to whether a major revision product offering is an Upgrade or a new product, COREL's opinion will prevail, provided that COREL treats the major revision product offering the same for its end user customers generally. If a question arises as to whether a new Software product is an Upgrade or a New Product, COREL's opinion will prevail.
 - Qualified Institution.** means primary, secondary, further and higher education institutions controlled by You.
 - Software.** means (collectively or individually, as the context requires) the COREL Academic Software product or products together with any Updates and Upgrades licensed by You under this Certificate and the object code of any Corel Academic Software products made commercially available by COREL and validly licensed by You under this Certificate together with any Updates and Upgrades licensed by You under this Certificate.
 - Update.** means a fix or compilation of fixes released by COREL during the term of this Certificate to correct operational defects (program bugs) in the Software and which is generally provided by COREL without additional charge to end users of its standard, retail, shrink-wrap versions of the Software.
 - Upgrade.** means a revision of Software released by COREL during the term of this Certificate that is consistently designated by COREL as an "Upgrade", rather than a New Product. In most instances an Upgrade will generally be designated by a version number change in the Software immediately to either the right or the left of the decimal (e.g. version 5.1 to 6.0 or version 6.0 to 6.1).
 - Use or In Use.** means, for a single user computer or workstation, the Software is considered In Use when any portion of the Software is either loaded in memory or virtual memory or stored on a hard disc or other storage device.
